LMS Editing Notes

1. The font of the Course text do not match the LMS font. Some fonts are serif and some are san serif, i.e. on page one—the note at the bottom is san serif but the rest of the test on the page is not. Gives the 'feeling' of being kind of disjointed. Also, most of the fonts on the CP website are san serif.

2. What is a Module?

Changed the word displays to maintains... (The Civic Plus Government Content Management System displays information in two places.)

Rationale: It displays the information on pages but aggregates or collects it in Modules as the two examples following the statement point out.

3. "You can access any module" Added "that you have permission for".

4. Complete List of Modules—Check the list. There may be a couple that do not show up on the list such as Activities which does show up in the list online.

5. Step One—Pick Your Category

Second line..."you must pick which Category you are wanting to....changed 'are wanting to' to 'you want to'.

6. Changed the sentence to focus on the user and not the writer..."If I go up to the module drop down" was change to "If YOU go up to the module drop down...same sentence "the first thing I would see..." changed to the first thing you will see...".

7. "Some of our modules" changed to "Some modules".

8. Common Field, Start/End Date:

Second paragraph abruptly ends at word stay. Added "active until the status is manually changed."
